## Below are examples of activities run through the chaplaincy service without religious or spiritual content:

- Breakfast program; Shed Program; visits to Kirra Haven Residential Aged Care facility; Mentoring; etc.
- Educational, Social & Emotional Support; Pastoral Care; One to One meetings with the chaplain.
- Extra-Curricular Activities, eg. Camps, excursions and school events.
- Lunchtime Programs eg: Games Club.
- Group Programs eg: Fun Friends; Friends for Life; A2B; Games Factory.

## Below are examples of voluntary student activities <u>with religious or spiritual content which require written</u> <u>consent:</u>

- SUPA Club/Boys/Girls Programs (children's lunch or after school program with spiritual content).
- Visiting Performers eg: drama groups, musical groups, etc.
- One to One meetings with the chaplain, including prayer if requested.
- Christmas Carols or other religious seasonal events.
